Researching Cosmetology Schools Leads to Barbering Career Meet Jennifer Grisham —

New Board Member for the TDLR Advisory Board on Barbering

Jennifer Grisham, TDLR's newest member of the Advisory Board on Barbering, knew as a child she wanted "to do hair." She assumed going to cosmetology school in her hometown of Austin would be her first step to a career as a cosmetologist.

But, while visiting prospective cosmetology schools she learned she would learn hair cutting techniques, plus be required to learn other curriculum requirements, for example, artificial nail application and care; subjects she had no interest in and didn't plan to use in her hair cutting career. "Forget it, I won't cut hair," Grisham says she told a school representative when presented with a curriculum that included too many "extras." The school representative must have seen something

special in the aspiring hair cutter because she suggested Grisham consider attending barber school. The rest is history.

Grisham completed her schooling at Austin Roffler Barber College, has held a Class A Barber license for 17 years and is an owner of a shop in Alpine, Texas, that includes two barbers and four cosmetologists.

Grisham outlines the challenges of barbering in west Texas but it is these challenges that lead her to serve as a board member to help the barbering industry grow. "I want to make it easier for Texans wanting to be a barber to achieve that goal. There is a barber shop in Alpine that has no barber and the nearest barber school is in El Paso. This is a region where individuals

can't afford to move away to go to school."

Cities and towns in west Texas are often miles from each other and the distance can make it impossible, or at least, difficult for students to live at home and attend barbering school.

"Moving to Alpine made me realize how underserved Texas is by the barber industry and barber schools," Grisham stated after the advisory board meeting. "We barbers must work together and find a solution that allows alternative certification for individuals unable to move and attend barbering school."

Orders Issued From September 2009 to April 2010

Every year the Texas Department of Licensing and Regulation (TDLR) publishes the top ten barbering violations in the *Stylist* and most recently in your Barber Newsletter. Several newsletter readers asked the Department to include a list of the people caught by TDLR for violating the Texas Barbering laws and rules. The violations listed below resulted in over \$80,000 in administrative penalties assessed.

Foot spas must be cleaned according to 16 Texas Administrative Code Ch. 82

NOTABLE DISCIPLINARY ACTIONS!

Maria Lucy Caballero.....d/b/a Klassic Kuts Barber Shop.....Grand Prairie.....\$1000

Caballero told TDLR investigators she performed barbering services on a client she knew had the contagious condition known as ringworm. She stated she saw the ringworms on the client's head but performed a haircut on the client after receiving permission from the client's mother to proceed.

16 Texas Administrative Code Ch. 82.102 (b) states: A licensee may not perform services on a client if the licensee has reason to believe the client has a contagious condition such as head lice, nits, ringworm; or inflamed, infected, broken, raised or swollen skin or nail tiddue; or an open wound or sore in the area to be serviced.

Morris L. Owens.....d/b/a Lynn's Barber Shop.....LaPorte.....\$500

A TDLR inspector attempted to inspect Lynn's Barber Shop on June 3, 2009. Owens refused to allow the inspector to perform a periodic inspection of the premises.

16 Texas Administrative Code Ce. 82.50(d) states: The barber establishment owner, manager, or their representative shall cooperate with the inspector in the performance of the inspection.

Ralph Sutherland.....Richardson.....\$2500

Sutherland, a barbering student, was caught cheating on the examination by the exam proctor. Sutherland was observed holding several sheets of paper while take the Texas Barber written examination. The sheets contained questions and answers to the barbering examination.

Using study notes, questions or answers obtained from another person or from previous examination attempts is not allowed. Texas Administrative Code Ch. 60.63(j)(6) states that very, very plainly. No cheating!
